

#### DO'S AND DONT'S OF SOCIAL MEDIA FROM A PI'S PERSPECTIVE:

- When posting photos make sure that you don't have any identifying info in the photo (house numbers, car license tag, locations, etc)
- Be careful about sharing photos with your children's information in them (school names, sports teams, locations etc)
- Do not share your personal location (be mindful of geotagged images)
- Only post about vacations AFTER returning from them.
- Don't post photos of people without their permission.
- Do share posts and info with 'Friends Only', keep your information private.
- Do have High Privacy settings on all Social Platforms.
- Don't Friend request or Follow someone until you know who they are.
- Do look and see if you have any friends in common.
- When someone you're not sure you know tries to friend you, look through their public photos and posts to confirm they are who you think they are.
- Do be cautious of posting or liking/sharing things that can be used to establish character.

### Do private investigators have to identify themselves?



If a private investigator is conducting surveillance in a neighborhood and they are approached by a neighbor questioning their presence in a neighborhood, they don't necessarily have to identify themselves, as this could compromise the integrity of their investigation. If a private investigator decides to identify themselves to someone it is usually because that information may help them during surveillance in a setup position or just to ease the minds of neighbors without hurting the integrity of their investigation.
