


REAL CASE STORIES FROM REAL DETECTIVES

#21-01S: MONETARY MOTIVES

Marnie and Dan had been married for many years when, unfortunately, he became suspicious that she may be having an affair because of her habit of coming home very late from work. 
Going through a divorce can be a very turbulent time in your life. Tensions often run high and these feelings can be exacerbated when there are children involved. There are so many considerations that go into determining a custody agreement and sometimes things don't go the way you expect them to. Sometimes it can even get ugly. Parental alienation is a tactic often employed by a disgruntled parent to effectively estrange a child from their other parent. If you or a loved one are going through a divorce here are some red flags to look for to ensure that your former partner is playing fair. If you notice any of these habits or behaviors speak to your lawyer about how this could impact your custody agreement.

against the other. Children may exhibit some hostility toward a parent as part of their processing of the emotions associated with the divorce. However, when this hostility is disproportionately applied toward one particular parent and not the other this can be a sign of alienation. While the child will exhibit hostility toward one parent their feelings toward the other parent will be a stark contrast. Most children perceive good and bad in both of their parents, an alienated child will see one parent as perfect and one as inherently bad. The child knows a lot more than they should about the divorce. If one parent is sharing the assumed failures of their child's other parent with the child this can poison the child against that parent and cause them even more emotional distress. The child has a choice about visitation, regardless of the court schedule. If the parent gives the child the choice of whether to see the other parent, this is a strong sign of alienation as they are allowing the child to decide which parent they prefer to spend their time with. The child is being used by the other parent as a spy. Some parents will ask the child to report back to the other parent after their designated visitation. Sometimes a parent is simply looking for information to use against the other during negotiations. The parent withholds information pertinent to the other parent's role in their child's life. (ie. intentionally not notifying the other partner of a major school or athletic event)

Kate Warne: The United States First Female Detective

Kate Warne is considered the first female detective in the United States. She was hired by Allan Pinkerton of the Pinkerton Detective Agency and was a key player in the failed assassination attempt of President Abraham Lincoln in Baltimore in 1861. Prior to the attempt, she had disguised herself as a rich Southern lady in order to infiltrate secessionist social gatherings in Baltimore. While at these gatherings, she discovered details of the assassination plot. For her work prior to and during the civil war, Warne was named one of Pinkertons' five best detectives by his own standards. She continued to work as a detective throughout the civil war and once it was over Pinkerton established the Female Detective Bureau, putting Warne in charge as "Supervisor of Women Agents." Kate Warne died in 1868, 35 years before women would be allowed to be detectives working on the police force.
